# Your Local Watershed Groups at Work

The Potomac Basin of West Virginia is home to some very active watershed associations, made up solely of volunteers. As you will read below, these non-profit groups - most of which are located in the Eastern Panhandle - work to protect local waterways by doing stream clean-ups and projects in the watershed (land area that drains to the waterway), water monitoring, float trips, and outreach to their communities and legislators. From east to west they are: Blue Ridge Watershed Coalition, The Opequon Watershed, Sleepy Creek Watershed Association and Warm Springs Watershed Association. The territory of Friends of the Cacapon River includes part of Morgan County in the Eastern Panhandle, but also extends south and west across

The Chesapeake Bay Program's **BMP** (Best Management Practice) Verification Ad-Hoc Action Team recently elected Dr. Elliott Kellner as its chair. Dr. Kellner, a member of West Virginia's Chesapeake Tributary Team, is Assistant Professor at West Virginia University, where he dually appointed in the Davis College of Agriculture, Natural Resources and Design and the Institute of Water Security and Science.

## Hands-On Activity for Kids

**DIY: Make a Bee House with Recycled Materials** 





#### You'll Need:

- Medium size can
- 2 rolls of toilet paper (empty)
- Sheets of paper
- Gorilla glue (or other kid-friendly glue)
- Tane
- Paint for the tin can (optional)

#### **Step By Step Instructions:**

- 1. Measure the length of your can and cut your paper in a way that the length of the paper roll will fit inside the can.
- 2. Roll the paper around a pencil to get the right shape
- 3. Then tape edge of the paper band to the roll to keep the diameter, remove the pencil.
- 4. Place the rolls inside the can, you can apply a thin layer of glue at the bottom of your can. Place your 2 toilet paper rolls where you wish inside the can and fill up the empty space with your paper rolls.
- 5. Find a location: The new mason bee house needs to be in an open, sunny spot which isn't shaded by plants, about 3ft from the ground. The fixing must be secure the can shouldn't flap and move about in the wind.

#### **Pesticide Collection for WV Residents - October 24**

The WVDA and the Berkeley County Solid Waste Authority are hosting a pesticide collection on October 24, 9 am-5 pm, at the South Berkeley Recycling Center at 637 Pilgrim St. Inwood, WV. There is no preregistration or fee to drop off pesticides. This will be open to homeowners and businesses, such as farms, orchards, golf courses, other pesticide landscapers, and applicators.

Listed below are some examples of acceptable material:

herbicide, Insecticide, rodenticide, fungicide, aerosol cans of insecticide (such as wasp sprays), weed & feeds, pesticide products no longer on the market, and other products that end in "cide."

Unacceptable items include:

Pressurized cylinders, cyanide, paint, cleaning gasoline, oil, products, medications, and other chemicals are not classified as pesticides.

The 2021 West Virginia Envirothon is currently scheduled to take place in the heart of Chesapeake Bay country in the Mountain State, at Cacapon State Park in Morgan County on April 15-16, 2021.

The WV Envirothon Committee is fully committed to holding the event this year.

If COVID-19 restrictions lead to a change in the Envirothon's date, location, or format, the competition may become a virtual event. Any decision will be made with the safety and well-being of students, advisers, staff, and volunteers as the highest priority. We will keep everyone updated as more information becomes available.

On Sept. 28, committee members and presenters got together at Holly-Gray Park in Braxton County to film teacher training sessions that teachers and students can use to prepare for the upcoming competition.

These training videos will be featured on the Envirothon Facebook page and available on the West Virginia Envirothon homepage (https://www.wvca.us/envirothon/) by the first week of November.

The WV Envirothon is an annual two-day competition for students in grades 9-12. Teams consist of five students who compete in five subject areas: aquatics, forestry, soils, wildlife, and a current environmental topic. Students learn about West Virginia's diverse ecosystem and how they can help conserve and protect it for future generations. Winners also receive college scholarships.

The high school team who wins the 2021 West Virginia Envirothon competition will compete in the national competition. The 2021 NCF-Envirothon will be at the University of Nebraska in Lincoln, held from July 25 to July 31, 2021.

# About WV's Potomac Tributary Strategy Team

Fourteen percent (14%) of West Virginia drains into the Potomac River and on to the Chesapeake Bay. In June of 2002, Governor Bob Wise signed the Chesapeake Bay Program Water Quality Initiative Memorandum of Understanding. By signing this memo, West Virginia agreed to develop goals and objectives to reduce nutrient and sediment loading to the Chesapeake Bay.

To help WV accomplish these goals, Project Teams began working in targeted watersheds. These groups build partnerships, gather funding, and identify priority projects that are most important to their local communities.

Reducing nitrogen, phosphorus, and sediment in local creeks and rivers will mean healthier water resources that are better able to sustain tourism, fishing, drinking water supplies, wildlife habitat, and other uses. Each one of us can act locally to help achieve these goals.
